A Message from Your Secretary-Treasurer



As we enter the early months of 2015, I'd like to pause for a moment and reflect back on 2014.

Last year was one of the busiest and most expensive political years in the history of our state.

Federal and State candidate races along with ballot initiatives and referendums

were all voted on across Alaska. While many candidates we supported were elected, some were defeated. So goes another election cycle.

In my opinion, the most important victory in 2014 was the defeat of AO-37, an Anchorage ordinance passed by the assembly by a 6-5 vote. AO-37 was an anti-worker ordinance that stripped almost all of the rights of union employees working in the municipality regarding mandatory subjects of bargaining.

This was a mini version of a right to work "for less" bill. If it was successful in Anchorage, it would have spread like wildfire around the state and hurt hard working Alaskan families everywhere.

Thanks to Teamsters Local 959's staff and the membership's efforts, along with many other Anchorage

labor unions, AO-37 was handily defeated by a large margin of 10,000 votes and ultimately had a major impact on the outcome of the race for the Governor and Lt. Governors election.

The defeat of AO-37 was watched by many across the United States. It sent a strong message that Labor is alive and well in Alaska! It was a great victory that all of Labor should be very proud of!







Anchorage Local 959 staff returned to the Walk for Warmth this year with their team dubbed "Tropical Teamsters". Joined by family and friends there were about 18 walkers and they raised little over \$2500 to support United Way's campaign to support rent and utility assistance for Anchorage families. Great job!

Kenai: Looking Back, Looking Forward

2014 was a busy year for the Kenai Peninsula! It began with a grievance filed against First Student (FS) in February when state -required safety inspection allotted times were reduced by FS. A separate grievance followed, in response to FS not paying drivers fire charter rates for transporting crews to fight the Funny River. FS and the union reached a mutual resolution in both cases.

In August, Teamsters rallied to support the UA Plumbers and Pipefitters, Local 367, during their strike against Enstar. Even though the rally was announced with little time to inform the membership, with the help of Kelly Bookey, we managed to



summon plenty of Teamsters. Retirees and members stood united on a Saturday afternoon with signs, and proudly displayed their colors at an all-

union rally, held at the Soldotna Enstar.

Due to an increase of packages shipping near the holidays, the peak mailing season started in November. United Parcel Service (UPS) clerks, drivers, and their "helpers" in Kenai, Homer, and Seward delivered in full swing; so much that UPS added another position to their hub in Kenai.

In December, Kenai members gathered together for an afternoon of fun, food, and prizes at the second annual family holiday party, hosted at Alaska Lanes Bowling. There was a noticeable increase in attendance compared to 2013. Thank you to the Local's staff for traveling from Anchorage to help! At the celebration, photographer/Brother Floyd Brand (First Student Kenai attendant) snapped shots of member families partaking in the festivities. Attendees donated 60lbs of food to the local food bank. Way to go!

301 South Peninsula Hospital Teamsters

Since 2014, Local 959 has been in negotiations (and subsequent mediation) with South Peninsula Hospital (SPH) over a new collective bargaining agreement. The Union bargaining team has always taken a fair and firm approach negotiating with the hospital. In addition to wages, pension and health benefits were major issues debated between the parties. A tentative agreement was presented to SPH members in November 2014. Then on December 5, 2014, balloting ran from 7:30 a.m. to 8:00 p.m., allowing everyone the opportunity to vote. Over 65% of the bargaining unit turned out to vote, resulting in 80% rejecting the tentative agreement. Even though the hospital had held meetings to encourage the unit to accept the tentative agreement, the members stood strong in rejecting it. Negotiations have already resumed. The bargaining team believes that reasonable minds will prevail, and a contract fair to the employees and the hospital will be achieved.*

Teamsters Local 959 represents over 300 members at the hospital as a wall to wall unit with over 60 different classifications. The bargaining unit includes registered nurses, therapists, lab scientists, dietary aides, housekeepers, social workers, nurse assistants, radiology technicians, patient account representatives, sonographers, phlebotomists, and facility engineers. Nine union shop stewards do an excellent job in representing fellow members on day-to-day grievance issues and conducting orientation for new Teamster members.

AO-37 Down In Flames


fter its passing in March 2013, and more than a year of unsuccessful attempts to repeal the law, Anchorage Ordinance 37's (AO-37) fate was placed into the hands of Anchorage voters in the November 2014 general election. Ballot Measure 2 was (overwhelmingly) voted down by more than 50% of the voters. This was a great victory for labor, but not without the long and hard fight.

Originally, the Anchorage Assembly passed AO-37 (6-5 votes) with Chairman Ernie Hall leading the charge, despite knowing hundreds of citizens had been denied the opportunity to testify in the matter. In addition to taking away many mandatory subjects of bargaining in negotiations of new contracts, this ordinance also jeopardized the Municipality of Anchorage (MOA) Transit funds. Millions of dollars would have been lost, driving property taxes up to cover the costs of continued services. Realizing this wasn't just an attack on Municipal employees (represented by Teamsters), but also on statewide employees (public and private), every labor effort banded together and rose to the occasion. As a result, by April 2013 there was a change in the Assembly Chair, and Assemblyman Hall almost lost his seat to an unknown write-in candidate.

Aware of the urgency at hand, Secretary-Treasurer Rick Boyles sent a letter to the Assembly in April 2014, explaining that the passage of AO-37 would place federal transit grants in jeopardy, which caught the attention of several Assembly members, giving them more time to carefully examine the law. Many of them came to see that there would be not only a negative impact on the city employees, but also on MOA property taxes. Unfortunately, Mayor Sullivan wasn't interested in seeing what the Assembly finally could.

The first appearance in court was just to seek permission to gather signatures, which finally happened six months later. The second court date was with Assembly members in midsummer 2014, and included last-minute negotiations with a comprise ordinance, but it was unable to sway enough votes to pass. After hundreds of hours of gathering signatures (to send AO-37 to the ballot), the fight then became over which election the ballot measure would be on! But the numerous occasions in court, more than one million dollars spent (from all Unions), thousands of volunteers, signwaving, and visiting voters door to door paid off: the "No on 1" campaign was successful. And in November, AO-37 went down in flames.

While this was definitely a historic fight for public sector Teamster members, it could not have been done without all the help from private sector employees. They wanted to support their fellow working families (some in the Fire or Police Department), and it showed in a big way.



THANK YOU to everyone who volunteered their time! Your effort is what really helped repeal AO-37.

sk Ted Wicken! When Ted was wrongfully terminated in April 2014, his shop steward gathered the facts, called his business agent and filed a grievance. However, after going through the first few steps of the grievance procedure, it was unsuccessfully resolved. It was consequently sent to an arbitrator for a decision.

The arbitrator's final and binding decision was presented in December 2014. Ted was awarded his back pay and was returned to work in his rightful place on the seniority board.



Annual Training for Teamster Business Agents

For the third year, Local 959 contracted with the Cornell University School of Industrial and Labor Relations to provide advanced instruction for the business representatives. Dan McCray, the Director of Cornell's Labor Relations Programs, and Debra Osofsky, an adjunct professor at Rutgers University, conducted the three-day school at the Anchorage Hall in December.

The focus for this year's program was contract writing. The instructors designed lectures and small-group workshops to refine the agents' skills in writing proposals, negotiating agreements, and drafting contract provisions to reflect the agreements made at the bargaining table. While Dan and Debra are both entertaining and lively speakers, the days were long and the work was difficult.

Continuing education, like our recent seminar, is an example of the Union's investment in its employees and in the quality of the service that the Local provides its members. Fairbanks Unions Offered a Helping Hand at Thanksgiving





BridgeHealth contracts with self-insured groups such as ours to find affordable and top-quality surgeries around the country. My misconception was that they would find some cheap place with mediocre doctors to do the work. Instead, I received expert, advanced care at a top-rated surgical facility.

Using the Teamsters BridgeHealth option, our deductible and out of pocket maximum are waived, so the member pays nothing at all out of pocket for the entire surgery process. Travel and hotel for the member and a companion are paid for, and the member receives \$100 per day for food and incidental expenses. Also included in our services was daily post-surgical

physical therapy right at our hotel. And still, using this option saved our union <u>significant</u> funds!

BridgeHealth assigned a great care coordinator who answered my questions, and provided a list of doctors and facilities to consider I said, "I want to go south and sunny with a good doctor." Their website had a very extensive list of all places around the country with all the ratings. They use a national rating database website: CareChex, and only contract with the top-tier CareChex rated providers they also do all reservations, scheduling, etc.

I narrowed my search to a center in Newport Beach, California. The surgeon, Dr. James Caillouette and the facility were rated as excellent, and in fact every aspect of my experience with

them was the best! I was accepted for surgery there and got a call from Dr. Caillouette, who said he did a (very advanced) minimally invasive, muscle sparing posterior hip approach. After reading his website, I found that he does 500 joint replacements and 150 arthroscopic surgeries a year. Take a look at his website to see all his honors and accolades at hipkneearthitis.com.

Also, in today's confusing and mysterious healthcare cost scene the website for his

surgical center, The Orthopedic Surgery Center of Orange County (oscoc.com), amazingly, lists the all-inclusive dollar price for each surgery!

The surgery went great and I was discharged within 23 hours and walking. A week later, at the post-op appointment, I walked out of his office and forgot my cane! Surprising to say about a major surgery it was a wonderful experience and the $+70^{\circ}$ weather and sun were a nice bonus in January.

2014 - 2015 Winter North Slope Season

The beginning of the winter work season in Prudhoe has kicked off and Teamster members have seen jobs coming through the hiring hall since the end of November for building ice roads with two companies, AFC and Nanuq. The two companies quickly ramped up the work load for numerous projects. From CD-5 (ConocoPhillips) on the western end of the oil field to Pt. Thomson on the eastern end and numerous other jobs in between. Between the two companies, they have the lion's share of ice road building jobs on the North Slope this winter. Doyon Associated has a daunting task of building 4 pipelines this winter for ConocoPhillips for the CD-5 project.

Doyon Associated has this winter season to complete all four pipelines, a 20" line 10 miles long, two 8" lines 7.5 miles long for one and 6.5 miles for the other and a 6" line that is 6.5 miles long, plus drilling/setting 905 VSM's (vertical support members) and 650 HSM (horizontal support members) with associated connections, saddles, and guide plates in addition to laying 9.8 miles of powerline and fiber optic cable. All of this before spring time comes.

Houston Contracting Company has two pipelines one from drill site 16 which is an 18" line and the other from drill site 17

which is a 16" line and both of those pipelines will run through drill site 3 and then on to Flow Station #2 with roughly 10 miles of pipe and 720 VSM's and 703 HSM's. Putting the 703 HSM's on the Sag river bridge will take some time and effort with the crews working

that high up in the air. AFC has been subcontracted to drill all of the 720 VSM's holes for this project, along with building the ice roads needed for the project.

Price Gregory has the Sharks Tooth project for ConocoPhillips. It consists of two-24" lines, two-12" lines, one- 8" line. All of this is at the new drill site 2S. These lines will tie-in to the current lines running along the Tarn road. AIC is subcontracted to build the ice road for this project. AIC is building a gravel road for Caelus Energy. We have been hearing that Norcon might have a chance of picking up a good sized job here in the next few months, with potential job calls for that project. The Norcon Scaffold job just keeps plugging along with a good

Training Trust CDL Road Test Fee

The Alaska Teamster Employer Service Training Trust (ATESTT)/ Center for Employment Education (CEE) are revising fees for Commercial Drivers License (CDL) road tests. The Training Trust through CEE has had a contract with the State of Alaska - DMV since 2000 to provide CDL road tests for all of Anchorage. Starting March 1st, 2015 the Anchorage DMV is getting back in the CDL testing arena and will end our exclusive Anchorage CDL road testing contract as of February 28. The ATESTT will still provide CDL road tests to all training trust eligible members for \$25 which is the same fee DMV charges for a CDL road test. If you are ATESTT eligible and need to use a vehicle for the road test there is no charge for the vehicle (and that would include any training necessary).
